Ms. Eadie welcomed the Committee and staff to her Municipality and invited all to attend Kincardine's ABC (Airplanes, Bikes & Cars) event being held on Sunday, July 31, 2011 at the Kincardine Airport. She expressed her passion for the importance of clean water and appreciated being kept up to date with the information on the website, including the Assessment Report. She conveyed her concern that Lake Huron be formally considered a source of water and that the health of Lake Huron is important to all of the Grey-Bruce region.

The Chair then introduced and welcomed Mr. Jim Coffey, CAO of Saugeen Conservation, Mr. John Cottrill, CAO of Grey Sauble Conservation, Ms. Allison Kershaw of the Owen Sound Office of the MOE, and Audrey Erin Holden of the Historic Saugeen Metis.

THEREFORE BE IT RESOLVED THAT the cost of hiring risk management officials, writing risk management plans, and monitoring and enforcing those plans for existing properties be borne by the users of the water system;

AND FURTHER BE IT RESOLVED THAT future expansion of systems and land use changes be borne by the proponents.

##### Planning Officials Working Group

The Program Supervisor and the Chair of this working group, SPC member Mitch Twolan, reviewed Report 6d and advised that the Working Group reviewed the policy packages respecting septic and dense non-aqueous phase liquids (DNAPLs) and passed the following motions endorsing the draft policies respectively:

“THAT the members present at the Planning Officials Working Group meeting support the policy directions contained in the policy package related to on-site

sewage systems as presented and recommend the package to the Source Protection Committee.”

“THAT the members present at the Planning Officials Working Group meeting support the policy directions contained in the policy package related to dense non-aqueous phase liquids (DNAPLs) as presented and recommend the package to the Source Protection Committee, with the policy on building permit denial being removed and revisions to the restricted land use policy.”

#### Agricultural & Rural Working Group

The Program Supervisor and the Chair of this working group, SPC member Dr. David Biesenthal, reviewed Report 6e and advised that the Working Group reviewed the policy package respecting septic and passed the following motion endorsing the draft policy:

“THAT the members present at the Agricultural and Rural Working Group meeting support the policy directions contained in the policy package related to on-site sewage systems as presented and recommend the package to the Source Protection Committee, with concerns about the availability of incentive funding.”

Andrew Barrie of the Ontario Ministry of Agriculture, Food & Rural Affairs (OMAFRA) explained the differences between nutrient management plans and nutrient management strategies at the Working Group meeting held July 14, 2011.

#### **The Committee took a break from 10:30 a.m. to 10:45 a.m.**

At the request of the Chair, SPC member, Mark Kraemer, temporarily took over as Acting Chair.

#### **7. New Business**

##### Bruce Power Presentation

Representatives from Bruce Power gave presentations respecting the science of tritium and the oversight programs in place at Bruce Power to monitor tritium emissions released from the Bruce Power nuclear facility and its effects on drinking water.

#### **The meeting recessed for lunch at 12:20 p.m. and reconvened at 1:10 p.m.**

The Chair, Mike Traynor, resumed chairing the meeting and thanked SPC member, Mark Kraemer, for stepping in as Acting Chair.

##### Septics Policy Presentation

The Program Supervisor reviewed the draft policy respecting on-site sewage systems (septic systems) and advised that the format of the document is being changed to make it simpler and easier to understand. A discussion respecting this draft policy followed and the Committee was advised that this threat would be revisited when the policy document is being finalized.

## DNAPLs Policy Presentation

The Program Supervisor reviewed the draft policy respecting dense non-aqueous phase liquids (DNAPLs) and advised that the format of this document is also being changed to make it simpler and easier to understand. A discussion respecting the disposal of hazardous waste followed.

### **8. Other Business**

Information about the bio-digester located in Georgian Bluffs was requested.

Raising the profile of Drinking Water Source Protection at the Association of Municipalities of Ontario (AMO) was discussed.


A discussion took place concerning the timelines given to SPC members to review policy documents. A need for additional time to review new or revised policy documents was expressed.

### **9. Confirmation of Next Meeting and Adjournment**


