Terms of Reference

The Project Manager reviewed Report 4b respecting the Terms of Reference and advised that there was a low turnout at the 3 public meetings held June 17th, 18th and 19th, 2008 but comments have been received. The public commenting period ends June 27, 2008 and it is unlikely that an extra SPC meeting will be necessary in July, 2008. The Project Manager confirmed that everything is on track and the original schedule is being met.

The Project Manager advised that the term "compensation" in the Terms of Reference may not be received favourably by the Ministry of the Environment (MOE). It was suggested that the SPC may wish to consider alternate wording such as "financial instruments". After a lengthy discussion, it appeared to be the consensus that the term "compensation" or "fair compensation" is the preferred wording.

Director's Rules and Consultation Sessions

The Project Manager advised that the Director's Rules have just recently been released and are available for viewing on the MOE Environmental Bill of Rights website (EBR) for a 45-day review period ending August 4, 2008. The SPC will be provided with the link to the EBR and were asked to review the Rules and forward any comments to the Project Manager prior to the next SPC meeting on July 25, 2008. The Rules and comments will be discussed at the next SPC meeting and forwarded to the MOE prior to the August 4, 2008 deadline. The Project Manager advised that the Summary Document is a good synopsis of the Director's Rules. There was a request that a copy of the Summary Document be provided to the SPC members.

Minister of the Environment Meeting Report

SPC member, Bruce Davidson advised that he attended a meeting with the Minister of the Environment Gerretsen on June 19, 2008 and reported the substance of this meeting to the SPC. A copy of the report is attached to these minutes.

Sandy Gott invited the SPC to tour her business, Ice River Springs, at Feversham ON following the SPC meeting in Markdale ON in April 2009 and noted that the SPC could also view the local wellhead at the same time.

The Project Manager advised that formation of the second proposed working group would be included in the agenda of the next SPC meeting.

MOE Consultation Regarding Implementation of the Clean Water Act – Bruce Davidson

Attendees –

Informal meeting including the Minister of the Environment, the Deputy Minister and Staff representation from the Ministry of Natural Resources (MNR), Conservation Ontario, Great Lakes organizations, Drinking Water Regulators, Water Guardians, Canadian Environmental Law Association (CELA), Source Protection Chairs, Project Managers and Members

Purpose -

To conduct frank informal discussions on challenges to the implementation of the *Clean Water Act* and provide recommendations to improve implementation of source water protection measures.

Issues Raised for Consideration -

- Sustainable and predictable funding for source protection implementation and appropriate remedial measures
- Source protection committee members must feel confident in both their abilities to protect drinking water in a comprehensive manner while adequately representing the concerns of their respective sectors
- Concurrent roll-out of information and funding for measure designed to protect those not covered by the *Clean Water Act* eg. private wells and potential clusters
- Clarification of methodology to be utilized in the assessment and designation of potential clusters
- Ongoing education and outreach to stakeholders regarding the consequences of contaminated water as well as government programs available to address a variety of remedial measures
- The need to address First Nations participation in the source protection planning and implementation process

Minister's suggestions -

- Percentage of funding for Early Actions could be increased in order to ensure higher uptake of the program
- Municipalities should not bear undue cost for the implementation of source protection measures
- Possibility of enhancing outreach and education measures to stakeholders
- Formal approach to First Nations to assist with participation and partnerships in the creation of source water protection plans and implementation
- Inclusion of climate change considerations to be incorporated into source protection plans
- Great Lakes issues regarding the interface of Great Lakes protection and watershed-based protection measures

• Database to be created in user-friendly form outlining all programs from various Provincial and Federal ministries and agencies which would be applicable to provide funding for source protection measures

Recommendations –

- In order to ensure the successful implementation of source water protection plans, MOE must be apprised of the true cost of implementation
- Increase funding percentage of Early Action programs
- Clarification of rules regarding assessment, designation and funding of clusters
- Continuation and enhancement of outreach measures to the general public and targeted stakeholder groups
- Enhance communication with agricultural representatives to comprehensively consult regarding potential impacts on agriculture including an explanation of how costs for remediation measures will be funded
- Clarification and explanation of measures being undertaken to successfully embrace First Nations as participants in the source protection Process
