The Chair introduced and welcomed new members to the Source Protection Committee, Amy Harrison as the new Environmental Representative, and Hugh Simpson and John Rodgers as the new Agricultural Representatives. 4. Matters Arising from the Minutes

The Project Manager advised that Staff is working on amendments to the Source Protection Plan (SPP) for the s.34 submission package.

5. <u>Correspondence</u>

Email dated May 28, 2023 from Amanda Greenfield respecting the Trans Canada Energy pumping station (Meaford) was **noted and filed.** The Project Manager advised that the pumping station is outside the purview of Drinking Water Source Protection because it lies outside the Intake Protection Zone (IPZ) and involves a military base under federal jurisdiction. There is the potential for impacts to the IPZ and this matter may be revisited when more information is available.

6. Reports

Administration Report 6a

The Project Manager reviewed Report 6a and advised that the initial version of the *Safe Drinking Water for First Nations Act* was repealed by the federal government in 2022 and there is a commitment to develop new First Nations drinking water and wastewater legislation in consultation with First Nations.

Well Updates

Chesley:

The Project Manager advised that a new test well was drilled in Chesley and results from a pump test will determine if this well is viable and will lead to further groundwater analysis and modeling.

Minto Pines:

A replacement well has been drilled and a groundwater analysis is being awaited, which may shift the location of the WHPA.

Kimberley-Amik-Talisman:

There are not currently any details respecting the proposed resort south of the Kimberley-Amik-Talisman well, but a group known as the Protecting Talisman Lands Association have engaged with DWSP Staff and several experts respecting the impact of a development in this location given the karst topography. Due to the lack of conclusive evidence respecting the karst impact on the well, DWSP would recommend an additional study as part of any development proposal.

Communications Report 6b

Children's Water Festival:

The activities were supervised by conservation authority staff, high school students and staff from other organizations. 7. New Business

Meaford Fire Report 7a

The Project Manager reviewed Report 7a and advised that, on May 25, 2023, a massive fire destroyed an auto repair shop on Highway 26 in close proximity to the Meaford drinking water plant and intake. The municipality quickly shut down the Meaford water intake due to concerns from contaminated water runoff. After four sets of expedited water samples were collected over a 72-hour period, and in cooperation with the MECP, the Ministry of Health, Grey Bruce Public Health, the municipality and Source Protection Risk Management Staff, the do-not-consume advisory was lifted. There was no Source Protection Risk Management Plan for this property as fuel storage on the property did not exceed the threshold that would require a Risk Management Plan.

Some lessons learned and opportunities for improvement in response to this event were for Source Protection staff to revisit the "Training Guide for Fire Fighters" with updated information on key actions fire departments can take when responding to a fire such as this within a vulnerable source protection area. A copy of the updated Guide was issued to all Fire Chiefs/Community Emergency Management Coordinators across the Region.

Salt Management Plan Templates Report 7b

The Project Manager reviewed Report 7b and advised that the salt management plan templates and measures for municipalities and operators are included in the updated amendments to the Source Protection Plan with a goal to establish a level playing field for the Counties, municipalities and

private contractors who apply salt to roads and parking lots. Risk Management measures for salt application, handling and storage were included in this report.

Scott's Point Wellhead Protection Area Report 7c

Currently, the new well is not properly centred within the 10-metre radius and adjustments will be made prior to submission to correct this, as well as any typos.
